Staff Remuneration Committee

Staff Remuneration Committee is a standing functional committee under the incumbent Board of Directors which appoint members to the Committee. The Committee shall have four to seven members with the Chief Executive Officer (as staff representative) and the Board Director responsible for administration being ex officio members. The Board Director will also sit as the Committee Convener. The Committee rules by simple majority voting and, in the case of equal voting, the Convener* is entitled to an extra deciding vote.

Responsibilities:

- 1) Review and recommend employment terms, service conditions and performance appraisals.
- 2) Review annual salary increment levels with reference to the salary trends of local employment market situations and government employees.
- 3) Consider the need for expansion or reduction of staffing establishment and consequent financial impacts.
- 4) Render advice to the Convener regarding additional hiring of staff when requested.
- 5) Provide suggestions and advice to the Board of Directors when requested.
- 6) To deliberate proposed amendments to the "Sowers Action Employee Handbook" which lists out in details other responsibility of the Committee. Amendment proposals should first go through the Chief Executive Officer/ Executive Officer before submitted for discussion. Final approval from the Board of Directors is required.

Insurance Selection Committee

Insurance Selection Committee is a consultative group with its members appointed by the Board of Directors and managed by the Executive Committee.

It should comprise not less than 6 members, including those from the Board of Directors or Executive Committee, ordinary members appointed for their financial expertise, a representative from the fundraising department, as well as independent persons who are invited for being practitioners in the insurance industry or involved in the management of insurance issues in their respective organizations.

The committee shall upon formation elect its convener at the first meeting.

Responsibilities:

- 1) Design and recommend an appropriate insurance framework to the Board of Directors to suit operation needs.
- 2) Review and select insurance service providers and follow up with their services.
- 3) Review and update insurance service needs on an annual basis, and make budgetary recommendations to the Executive Committee.
- 4) Provide counselling, feedback and assistance regarding insurance issues to the Board of Directors, Executive Committee and various fundraising committees upon request.
- 5) Render assistance in rescue arrangement in the event of incidents and insurance claims.
- 6) Members should make declaration of interests in deliberating insurance issues and could not take part when there is a conflict of interests.
